13. LIQUIDATED DAMAGES

The center will at all times abide by the job safety measures and other Statutory requirements prevalent in India and will keep free and indemnify the ESIS from all demands or responsibilities arising from accidents or loss of life, the cause or result of which is the center negligence or misconduct. The center will pay all the indemnities arising from such incidents without any extra cost to ESIS and will not hold

the ESIS responsible or obligated. ESIS may at its discretion and shall always be entirely at the cost of the tie up center defends such suit, either jointly with the tie up center or separately in case the latter chooses not to defend the case.

16. ARBITRATION

The provision of Arbitration and Conciliation Act, 1996 shall apply to the arbitration proceedings. The venue of the arbitration proceedings shall be at office of Director ESIS Uttarakhand. Any legal dispute to be settled in Dehradun jurisdiction only.

17. MISCELLANEOUS

- A. Nothing under this Agreement shall be construed as establishing or creating between the Parties any relationship of Master and Servant or Principle and Agent between the ESIS and Empaneled Center.
- B. The Empaneled Center shall not represent or hold itself out as an agent of the ESIS.
- C. The ESIS will not be responsible in any way for any negligence or misconduct of the Empaneled Center and its employees for any accident, injury or damage sustained or suffered by the referred patient/ESIS beneficiary or any third party resulting from or by any operation conducted by or on behalf of the center or rendering its service under this Agreement or otherwise.
- D. The Empaneled Center shall notify the Government of any material change in their status and their shareholdings or that of any Guarantor of the Empaneled Center in particular where such change would have an impact in the performance of obligation under this Agreement.
- E. This Agreement can be modified or altered only on written Agreement signed by both the parties.
- F. Should the Empaneled Center get wound up or partnership be dissolved, the ESIS shall have the right to terminate the Agreement.
